FINAL JUDGMENT

At the hearing on this cause, the Appellee/Landlord appeared through attorney of record, John M. Daves. Appellants/Tenants, Khalif Abdul Muhammed and Latreese Cooke, ~~appeared~~ **although provided with notice of the trial setting as required by law, failed to appear** at trial of this matter.

The Court has considered the pleadings and official records on file in this cause and the evidence and is of the opinion that a judgment should be rendered against Appellants/Tenants, Khalif Abdul Muhammed and Latreese Cooke, and for Appellee/Landlord, Gustavo Torres.

It is accordingly ADJUDGED that Gustavo Torres, Appellee/Landlord, recover from Appellants/Tenants, Khalif Abdul Muhammed and Latreese Cooke:

1. Immediate possession of the subject Premises commonly known as 11704 Morning View, Del Valle, Travis County, Texas 78617.
2. \$ 6,500 as rent owed through the date of judgment.



3. \$ 26,522.00 as attorney's fees;
4. Costs of Court;
5. Postjudgment interest at the maximum rate allowed by law per year on the total judgment from the date of judgment until paid.
